#### **6 DAY STANDSTILL:-**

If cattle, sheep, goats or pigs are moved onto a holding then <u>no</u> cattle, sheep, goats or pigs can be moved off the holding within six clear days of that movement (or 20 days for pigs). The standstill starts when the animals are brought onto the holding, and the six day count starts on the following day.

### FOOD CHAIN INFORMATION DECLARATION

Pigs on the holding are not under movement restrictions for other animal's disease or public health reasons (excluding a 6-day standstill).

All Prime Pigs/Cull Sows & Boars sold are guaranteed to be free from withdrawal periods for all veterinary medicines and other treatments administered to the animals while on this holding and previous holdings.
